2019 All Media Juried Art Show - \$1200 Prize Money - Rules

Halifax County Arts Council (HCAC) is sponsoring a juried All Media Art Show with \$1200 in total prize money offered. The show will be held at Halifax County Arts Council Gallery at 1027 Roanoke Ave., Roanoke Rapids, NC 27870 from April 7- May 17, 2019. Prize offerings will be \$500 first place, \$300 second place, \$200 third place and \$100 fourth place and four \$25 honorable mentions. The Juror is Mark Gordon.

Entries

Two and three dimensional work is acceptable including but not limited to: paintings, drawings, photography, sculpture, pottery, glass, collage, metal, wood, stone and jewelry. All work to be considered must be original: conceived and created by the entrant. Work cannot be done under supervision or with input from others. If the work is a collage all materials must be original to the artist plus created by the artist. Pieces that are on wrapped canvas are acceptable unframed only if the sides are painted and no staples are showing. All two dimensional work framed must have hanging wire (No saw tooth hangers). Work is not to exceed 42 inches in any direction including the frame and support materials. All art work entries must be for sale.

Entry Fee

There is a \$10 non-refundable entry fee for each individual piece of artwork submitted. There is no limit on the number of pieces an artist may enter. No work will be considered without the appropriate entry fee, completed entry form and identification on the piece. Identification includes artists name, phone number, title of piece, medium, size and price. The total number of pieces selected depends upon total number entered and juror's selection. Artists will be notified of selected works by Thursday, March 28, 2019. (email preferred)

Submitting Work for Consideration

1. By email: the shortest side of the photo should be no smaller than 1200 pixels (4") Send to: jmathewssr45@gmail.com

Crop to show only the image with no text, matting, frame or background. Name photos as follow: Artists last name-first name-entry#-title-size.jpeg Example: doe-jane-1-beagle-11-14.jpeg Please submit one photo per each two dimensional entry and two photos per each three dimensional entry. Artwork that differs greatly from the photos may be disqualified.

Submissions by email must be emailed and check for entry with completed form mailed to: **Halifax County Arts Council, P.O. Box 374, Roanoke Rapids, NC 27870 and must be postmarked by March 20, 2019.**

2. Artwork may be dropped off in person at the HCAC Gallery, 1027 Roanoke Avenue, Roanoke Rapids, on Saturday, March 23, 10 AM-2 PM

All work must be identified on the back with the artists' name, phone number, medium, size and price. Artwork delivered to HCAC but not selected for the show, must be picked up by Wednesday April 3, 10AM-4PM.

Acceptable Work and Museum Commission

Artwork selected for the show from email submissions must be delivered to HCAC Gallery Saturday, March 30, from 10 AM-2 PM. A person may bring multiple artists' work. However, art work cannot be sent by Fed Ex, UPS, or Postal Office. The show will hang from April 7 - May 17. All accepted work must hang for the duration of the show. HCAC will retain a 20% commission on artwork sold during the show. Limited edition prints of accepted work (no more

than 3 prints each, wrapped, on a hard surface, labeled and priced can be delivered on or before the opening reception and will remain throughout the show. All unsold artwork must be picked up by Sunday, May 19, 3pm.

Work not picked up

Unless prior arrangements have been made, artwork not picked up prior to May 19 shall be liable for a removal fee of fifty (50) dollars and a storage fee of two (2) dollars per day. HCAC shall incur no liability for damage to items placed in storage. If you want someone else to pick up your work; they may do so with your permission. The name of the person picking up artwork will be recorded. ID must be shown.

Liability

Every care will be given to submissions. Liability cannot be assumed for loss or damage of submitted works. Artists wishing protection should insure their works independently. Most homeowner's insurance policies cover personal property located off-site.

Prizes

The juror will determine all prize money allocations for first, second, third, fourth and honorable mentions. The winners will be announced and prizes awarded at an Awards reception on Sunday, April 7, 3-5 PM.

- **Saturday, March 23, 10-2** - Deadline for entries dropped off in person at HCAC Gallery
- **Thursday, March 28** - Artists are notified of works selected for the show
- **Saturday, March 30, 10-2** - Deadline email submitted artwork selected for the show delivered to HCAC Gallery
- **Wednesday, April 3, 10 AM-4 PM** - Deadline for entries delivered to HCAC, but not selected for the show must be picked up on
- **Sunday, April 7 to Friday, May 17** – Exhibition Shown in Gallery. **To make appointments for viewings of the exhibit when in the area call Carol Moseley 252-537-8657.** The Gallery will be hosting local events/meetings during the exhibition creating opportunities for the art work to be viewed and purchased.
- **Sunday April 7, 3-5 PM** – Award Reception and **Monday, April 8, 6 -8 PM** - Sip n' See Reception. Both receptions are free and open to the Artists and Public.
- **Saturday, May 18, 10 AM-1 PM or Sunday May 19, 1-3 PM** - Unsold artwork must be picked up at the Gallery
